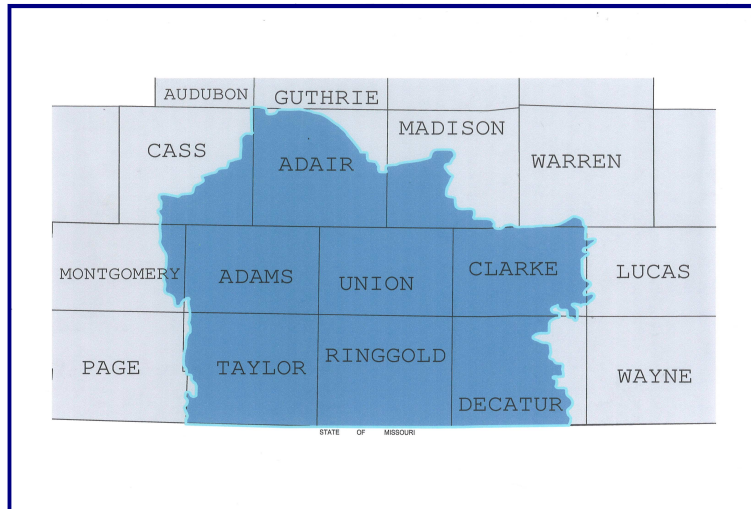

Hooking up to SIRWA

- Complete the application for a water meter service and submit to SIRWA along with the application fee.
- We will then submit your application to SIRWA's engineer in order to determine which pipeline will provide optimum connection and to assure that we have the capacity available to service your water needs.
- We will then prepare and send out your estimate along with all necessary paperwork to install the metered service. (Meter pit must be set by a driveway)
- Once you complete and return **ALL** the papers to SIRWA, along with the final payment, we will submit your application to the IDNR for review and approval, which can take up to 6-8 weeks for approval.
- After all paperwork has been approved you will be added to the installation list for the contractor. Services are installed in the order in which the paperwork and payment were received.

FACTORS AFFECTING COST

1. Distance from existing pipeline to pit location.
2. Cost of pipe at the time of request.
3. Availability of the 'Added User Program' funds (currently there is up to \$1,000 available to help with the cost of bringing the pipeline to you)

CURRENT COSTS INVOLVED (not covered by the Added Users Program)

\$100 - Membership fee (1 time fee)

\$1,000 - Connection fee

- * New installations require a 10 year contract agreement (ask for details)

Costs involved that the Added Users Program are applied to:
